

**EMERGENCY MEETING MINUTES
DUNCAN COMMON COUNCIL
TUESDAY, JUNE 30, 2020; 5:30 PM
DUNCAN TOWN HALL; 506 SE OLD WEST HIGHWAY**

CALL TO ORDER: MAYOR THURMAN CALLED THE MEETING TO ORDER AT 5:30 PM.

ROLL CALL: COUNCILMEMBER DEBORAH MENDELSON, VICE-MAYOR VALERIE SMITH, MAYOR ANNE THURMAN, AND TOWN MANAGER JOHN BASTEEN JR. ARE PRESENT. COUNCILMEMBER JILL WEARNE AND TOWN ATTORNEY JOHN GRIFFITH ARE PRESENT BY PHONE. COUNCILMEMBER SUSAN RIOS IS ABSENT. QUORUM PRESENT.
